The three candidate municipalities for the European **Volunteering Capital 2025** title are **Avilés, Mechelen, Salamanca**.

The deadline for applications for the European Volunteering Capital 2025 was **June 2nd 2023**. The information provided in the application form will count as 70% of the final score allocated to each candidate. 30% of the score will be allocated based on the video and the presentation of the candidature during the CEV Autumn Volunteering Congress 2023 on October 2nd 2023 in Dubrovnik (HR).

The jury of key personalities connected with volunteering, representing civil society, the private and for-profit sector, as well as the EU institutions, will assess the candidates. The judging criteria is based on their strategies, policies, and programmes in connection to the Blueprint for European Volunteering 2030 and to the CEV Volunteering Policy Statements. Evidence about their engagement with, and support for, the European Solidarity Corps when the applicant comes from an EU member state is also required. Applicants are also asked to indicate if they are signatories of the Integrating Cities Charter.

The winner will be announced in Trondheim, Norway on December X 2023.
