## Session

In 2018 the EU has launched the **European Solidarity Corps** as a way to encourage, facilitate and promote solidarity in Europe. Acting in solidarity to secure and protect the rights and values of others is the basis of the European Union. Millions of citizens volunteer all across Europe, driven by a **sense of solidarity and community**, and a wish to actively address the needs and injustices that they see around them. Citizens of all ages and backgrounds voluntarily come together to find common solutions to shared challenges, in much the same way that Member States do in the European Union. A better understanding of this common approach to problem solving will enable **citizens**, the EU framework in which they live, and the EU institutions that facilitate it, gain a **closer understanding**.

**Volunteering**, as an active expression of solidarity in which millions of citizens in Europe engage, sets the frame for the lab by former, current & future holders & candidates of the **European Volunteering Capital** title, (an initiative that is co-financed by the Europe for Citizens Programme and the European Volunteer Centre (CEV)). An important part of the lab will be sharing experiences and presenting **local and regional strategies** that seek to promote **solidarity, engage citizens and help them make the link to EU policies and programmes**. "World cafe" discussions will enable participants to share ideas and perspectives about solidarity and volunteering in small groups.
