A bit of history:

CEV's origins lie in an initiative by 7 volunteer centres, Association pour le Volontariat (Belgium), Centre National du Volontariat (France), the National Centre for Volunteering (UK), Centro Nazionale per il Volontariato (Italy), Landelijk Steunpunt Vrijwilligerswerk (Netherlands) and Plataforma para la Promoción del Voluntariado en España (Spain). These organisations first convened at a meeting organised in Lucca, Italy, in 1989.

The outcome of the meeting was a joint declaration for increased European cooperation. On the basis of this declaration the Vlaams Steunpunt Vrijwilligerswerk, Flemish Volunteer Centre, was mandated to establish a new organisation registered in Brussels. CEV was founded in February 1990 & in 1992 was officially granted the status of "international non-profit organisation".

On 5 December 1995, CEV organised the **first ever European Day for Volunteering in the European Parliament**, in Brussels, Belgium, with the active support of the European
Parliament, the European
Commission, the Council of the European Union and UNESCO.

CEV's initiative and facilitating role was a crucial element in the civil society campaign for **the European Year of Volunteering 2011,** together with partner networks active in volunteering at the European level.

These networks formed the 'EYV 2011 Alliance' and CEV was mandated to host the Secretariat for the implementation of the civil society strand of EYV 2011 from 2010 to 2012 with a project grant from the Europe for Citizens Programme.

The VOLCAR project aims to deliver guidance for volunteers to raise their employability through support in getting their learning outcomes validated and recognised. The VOLCAR Project is an Erasmus+ Strategic Partnership project coordinated by EDOS Foundation (The Netherlands) and the partners are CEV and volunteer centre BONSAI (Dubrovnik, Croatia). The project is being implemented between September 2015 and August 2017.



GR-EAT- Guidelines for Recognition European Advanced Tool aims to enhance the recognition of Non-Formal and Informal Learning and to provide youth-led organisations with support & guidance to implement internal systems of recognition of the competences of their volunteers. AEGEE, in partnership with WOSM, YEU and La Ligue implement this Erasmus+ Strategic Partnership project between November 2014 and November 2016. CEV is a member of the European Advisory Board providing advice and guidance on the intellectual outputs.



SAFE (System for recording and valuation of volunteer work as a means of improving transparency and efficiency in the economic management of NGOs) aimed to collect information on the different types of volunteer work in the Czech Republic and to improve the record keeping of volunteer hours at national level in order to reach a clearer understanding of the value of volunteering. The project was led by CRDM (Czech Council of Children and Youth / Česká rada dětí a mládeže), with CEV and Green Circle as partners. It was funded through the European Social Fund and implemented between November 2013 and June 2015



The EVARS (Elderly Volunteers- A resource for the Society) project aimed to improve the potential of senior volunteers, without professionalising their role, as an extra and valuable resource in society. The project consortium consisted of 5 partners from 4 countries & the lead partner was University College Lillebælt from the Region of Southern Denmark. The South Denmark European Office was the co-ordinator. The project was implemented between December 2013 and November 2015 and was funded by European Commission Lifelong Learning Programme. CEV was a member of the European Reference Group.

Capacity Building Conference "PICK AND MIX – a multi-perspective approach to volunteer centres" 23-24 April 2015 | Zadar, Croatia





The CEV Capacity Building Conference "PICK AND MIX — a multi-perspective approach to volunteer centres" provided opportunities for 80 participants from 15 countries to get an insight into innovative and new approaches to volunteer management as well as the role of volunteer centres in the development of volunteering, and the community as a whole. 9 workshops were delivered by CEV Members:

Advocacy







Volunteering is directly relevant for several EU policy fields: Recognition and Validation of NFIL, EU Aid Volunteers, Erasmus +, Citizenship, Citizen's Dialogue, Health and Well-being, Active Ageing, Life-Long Learning, CSR, Economic Growth, Neighbourhood policies, Work-Life balance, etc.

The creation of an enabling environment for volunteering in Europe is a priority for CEV. In order to achieve this it is crucial that EU policies are co-ordinated and that volunteering is measured in a comparable way. CEV staff and volunteers work with policy-makers to develop more effective, evidence-based policies for volunteering.

The **CEV Seminar on Volunteer Measurement** took place on 18 March at the King Baudouin Foundation in Brussels, providing space for discussion and an exchange of views about the data collected by the European countries that have implemented or partially implemented the ILO Manual on the Measurement of Volunteer Work







The CEV "Volunteering in European Welfare & Social Services" VIEWSS Final Conclusions Presentation was hosted by MEP Brando Benifei at the Red Cross EU Office in Brussels on 24 February.

Networks

Whilst a network itself CEV is also an active member of European and international networks:















Civil Society Europe is the coordinating body for European networks of civil society organisations that are willing to work towards regenerating the European project around the shared values of Equality, Solidarity, Inclusiveness and Democracy. In 2015 CEV hosted the Civil Society Europe Secretariat.

The EESC Liaison Group with European CSOs and networks provides the only institutional bridge to the EU institutions, thereby establishing vertical civil dialogue, in accordance with Art. 11(1) of the Treaty on European Union (TEU), and offering a space for synergies between different actors on issues of common interest, and thus creating a place for horizontal civil dialogue (Art. 11(2) TEU).

The EQF Advisory Group supports Member States to put in place NFIL validation arrangements by 2018, as agreed in the 2012 Council Recommendation on Validation of Non-formal and Informal Learning, allowing individuals to obtain a qualification (or parts of qualifications) on the basis of validated knowledge, skills and competences gained through informal and non-formal experiences such as volunteering. The role of the Youth Expert Group is to support the implementation of Youth Policy in all Member States. The sub-group on **Mobility of Young Volunteers** aims to facilitate the implementation of the Recommendation on Mobility of Young Volunteers across the EU

The European Alliance for Volunteering acts as a collaborative and supportive hub for European, national and regional organisations involving volunteers or who support or promote volunteering to advocate for positive change in the volunteering sector.


The Conference of INGOs of the Council of Europe constitutes civil society's pillar in the Council of Europe "quadrilogue" with the Committee of Ministers, the Parliamentary Assembly and the Congress of Local and Regional Authorities.

The Third Sector Impact research aims at analysing the conceptualisation, size, scope, and impact of the third sector, the barriers it is facing, and potential avenues for overcoming these barriers in European countries.

The ITSSOIN project (Impact of the Third Sector as SOcial INnovation) investigates the impact of the Third Sector and civic engagement on society, which goes beyond their economic benefits or the natural virtue of caring for others.

European Volunteering Capital Competition



Lisbon is European Volunteering Capital 2015

The official opening ceremony of the European Volunteering Capital 2015 took place on 5 March in Lisbon. CEV Vice President Joao Teixeira was present and thanked the municipality for the support shown to volunteering and the volunteers for their commitment and contribution. Several events were organised (meetings, workshops and a volunteering marketplace) to celebrate the title

On 4 December, together with the closing ceremony for Lisbon European Volunteering Capital 2015, the City of Lisbon also hosted the Winners Announcement Ceremony for the #EVCapital competitions 2016 and 2017. The event was attended by the candidate municipalities and other stakeholders.







London was awarded the title European Volunteering Capital 2016 and Sligo will be the European Volunteering Capital 2017.

The winners were chosen by a jury of international experts evaluating the way in which PAVE recommendations are implemented by the candidate municipalities. There were **11 candidates from 5 countries for 2016 and 8 candidates from 5 countries for 2017**: Belfast (2016, 2017), Bruges (2016, 2017), Cagliari (2016, 2017), Cascais (2016), Edinburgh (2016), **London** (2016, 2017), Lucca (2016), Perm (2016, 2017), Rome (2016), **Sligo** (2017), Varese (2016, 2017), and Viterbo (2016, 2017).














In 2015, the CEV-EVEN Workbook and a video clip describing EVEN objectives were published. The CEV-EVEN Workbook is available in English, Dutch, French, Italian, Polish, Portugues, and Spanish.

The CEV-EVEN Workbook is designed by EVEN members to help volunteer-involving organisations implement employee volunteering (EV) projects. It is useful for organisations that are ready to start their first projects and have already agreed internally that EV has the potential to help them meet their objectives and bring added value to their work. The workbook guides the user through a process that emphasises the importance of ensuring a common understanding in the organisation about the purpose and added value of EV projects before decisions towards implementation are made.

The user is also assisted in understanding the different possible models of EV in order to select the most appropriate for the agreed objectives and specific circumstances of the organisation, project and the needs of the beneficiaries.


The steps needed to implement successful EV projects are described together with specially designed exercises and tools to assist organisations and their partner employers prepare, implement and follow up impactful EV activities.
